#### Article V PURPOSE AND POWERS OF THE ASSOCIATION

This Association does not contemplate pecuniary gain or profit for the members thereof, and the specific purposes for which it is formed are to provide for maintenance, preservation and architectural control of the residence Lots and Common Areas within the subdivision known as STONEY RIDGE PUD, as more particularly described in the Plat thereof, recorded in the real estate records of Garfield County, Colorado; to take all actions required of it by the Declaration of Colorado Common Interest Community Act for Stoney Ridge PUD; and have all other powers, rights, and privileges allowed by law.

#### <u>Article VI</u> MEMBERSHIP

Every person or entity who is a record owner of a fee or undivided fee interest in any Lot which is subject to assessment by the Association, including contract purchasers, shall be a voting member of the Association. The foregoing is not intended to include persons or entities who hold an interest merely as security for the performance of an obligation. Membership shall be appurtenant to and may not be separated from ownership of any Lot which is subject to assessment by the Association.

#### Article YII BOARD OF DIRECTORS

The affairs of this Association shall be managed by a Board of Directors, who need not be members of the Association. The number of directors may be changed by amendment of the By-Laws of the Association, as stated in more detail in the Declaration.

### Article VIII DISSOLUTION

Upon dissolution of the Association, other than incident to a merger or consolidation, the assets of the Association shall be dedicated to an appropriate public agency to be used for purposes similar to those for which this Association was created. In the event that such dedication is refused acceptance, such assets shall be granted, conveyed and assigned to any nonprofit corporation, association, trust or other organization to be devoted to such similar purposes.

## Article IX INDEMINFICATION

The Association shall indemnify each officer and director, including former officers and directors, to the full extent permitted by law.
