IMM recommended a committee be formed for covenant enforcement. Owners are encouraged to report any violation to IMM so they can address them per the governing documents. IMM will send out a reminder to the membership with the section of the Declaration on "Use Restrictions" so owners are reminded of the rules.

### VI. Board Election

Jodie McGrew and Tommy Waltner are current Board members, and both agreed to serve another term. Karen Johnson volunteered to join them in serving on the Board and the members in the room unanimously approved all three owners to serve as their Board of Directors. More involvement from the membership is encouraged as a quorum of 16 votes (1 vote per lot, duplex lots get ½ vote) is required for these meetings to be official.
