

BEFORE beginning any exterior improvement project, submission of this completed application to the Deerfield Park Homeowners' Association Architectural Control Committee is required.

This application process is in accordance with the Declaration of Covenants, Conditions and Restrictions (CC&R's) and Design Guidelines for Deerfield Park Homeowners' Association.

Instructions:

This is to assist the homeowner in ensuring the application submittal includes all information necessary for a thorough review process.

Projects include, but are not limited to the following:

- House Construction
- Landscaping, Irrigation, and Drainage
- Fence, Wall, Screening Device
- Any exterior project requiring a building permit from the City of Rifle

Before work on the project begins, the homeowner must supply the Association Manger with a copy of:

- The selected contractor's certificate of necessary insurance coverage.
- All required building permits.

The Architectural Control Committee will use the information provided to evaluate your application. A majority of committee members is required for application approval. The Committee shall approve or disapprove any plan or request within thirty (30) days. Homeowners must notify the Architectural Control Committee when work has been completed.
