Upon dissolution, the assets of the corporation shall be applied and distributed in the manner provided by law for nonprofit corporations. The Executive Board shall adopt a resolution recommending a plan of distribution and directing the submission thereof to a vote at a meeting of Members entitled to vote thereon. Such plan of distribution shall be adopted upon receiving at least two-thirds (2/3) of the votes which the Members present at the meeting or represented by proxy are entitled to cast. Any corporate assets, or proceeds in liquidation of such assets shall be distributed equally among the Lots and Units. The share to which each Lot or Unit is entitled shall be distributed to the Owner of that Lot or Unit. If a Lot or Unit is owned by multiple parties, the equal distributive share to which the Lot or Unit is entitled shall be distributed in its entirety to the several Owners who shall determine the apportionment of such share as among themselves.
