BEFORE beginning any exterior improvement project, submission of this completed application to the Valley View Village Homeowners Association Architectural and Design Committee is <u>required</u>.

This application process is in accord with the Declaration of Covenants, Conditions and Restrictions (CC&R's). Homeowners are required to be familiar with the CC&R's and regulations and to comply with them.

Instructions:

This is to assist the Homeowner in ensuring the application submittal includes all information necessary for a thorough review process.

Projects include, but are not limited to the following:

- 1) Deck restoration, including replacement, repair, or refinishing.
- 2) Satellite dish installation location.
- 3) Evaporative cooler or air conditioner replacement, including roof jack.
- 4) Replacement windows and doors.
- 5) Outdoor plantings or irrigation.
- 6) Any project requiring work on the exterior of your unit.

The Homeowner must contact the Association Manager to make certain that the contractor to be hired by the Homeowner for the project has the necessary insurance coverage & licenses to work on the exterior of your townhome unit.

Before work on the project begins, the Homeowner must supply the Association Manager with a copy of:

- 1) The selected contractor's certificate of necessary insurance coverage.
- 2) All required building permits.

Kindly complete the attached application form in its entirety. The Architectural Committee will use the information provided to evaluate your application. Applications are typically reviewed within seven (30) days of submittal. Approvals expire in one (1) year; Approved projects not completed within one (1) year of application require are required to resubmit an application for approval.
